Interest-free loans are available to income eligible individuals who are 60+ or have a disability for the purpose of securing and remaining in safe, affordable housing. The borrower determines the repayment schedule.

Am I Eligible?

An applicant must...

- Be at least 60 years of age OR be 18 years of age or older with a disability.
- Have a **household** income at or below 200% of the Federal Poverty Level.
Annual household income at or below:
 - \$31,296/annual (i.e. \$2,608/mo.) **SINGLE**
 - \$42,300/annual (i.e. \$3,525/mo.) **COUPLE or 2-PERSON**
- Must show the need for funds.
- Must live in Bridgeport, Darien, Easton, Fairfield, Greenwich, Monroe, New Canaan, Norwalk, Stamford, Stratford, Trumbull, Weston, Westport or Wilton
