Southwestern CT Agency on Aging (SWCAA) is pleased to announce the application for *Focal Point Designation*. The application period is open through May 5, 2025. Please consider applying for this important designation.

#### What is a Focal Point?

A focal point is a highly visible facility where anyone in a community can obtain information and access to aging services. As defined by the Older American's Act, it is a point of entry for accessing aging and disability services. Focal points are established to encourage the maximum collocation and coordination of services for older individuals. To older adults, it is a well-known, accessible place to turn for information, services, and opportunities. To families, it is a resource to support their efforts in caring for older relatives. A focal point is a visible sign of the community's caring for its older adults.

Focal point designation aligns with the development of an Area Plan, a plan for meeting the needs of older adults. Applications are reviewed by SWCAA's Focal Point Committee and approved by the SWCAA Board of Directors.

### **Recognition and Designation Benefits**

Focal Points will be showcased to the community at-large through various social media platforms. Designation benefits include featured presence on the SWCAA website, networking and training opportunities, and achievement of designation status to reference on various grant applications and marketing campaigns conducted by Focal Points. In addition, all Designees will receive special recognition at the SWCAA Annual Meeting in October.

#### Focal Point Criteria

Required Focal Point criteria:

- a. Provide information, referral and assistance, connecting individuals with resources to help meet their needs, and
- b. Provide, identify or refer to community organizations or aging network partners for seamless delivery of various programs and services. Such services include but are not limited to:
  - Meals and nutrition
  - Health, Fitness, and Wellness
  - Transportation
  - Public benefits counseling
  - Employment assistance
  - Volunteer and civic engagement
  - Social and Recreational
  - Education and arts
- c. Meet applicable health, safety and accessibility standards.
